Dubna State University has a position in TOP-100 Best Russian Universities Ranking. The University was founded and developed in the science city of Dubna. The city gained international reputation through fundamental scientific discoveries and is now becoming one of the largest innovative centers of Russian Federation. The University has modern infrastructure (5 academic buildings, 4 dormitories, the Palace of Sports), features unique equipment and laboratories complete with all the necessary components, classrooms, scientific and production locations, engineering and prototyping centers. The University produces highly-qualified specialists for different spheres and cooperates with high technology companies of special economic zone «Dubna». Rules for authors

- Every author can submit no more than two reports for publication. In case of submitting two reports, at least one of these (or both) should be co-authored.
- The text should be typed in *Microsoft Word*. The total volume of the thesis together with all figures and tables should not exceed 2 pages of A4 format with margins of 2.5 cm on each side. The text of the report should be typed using 11p Times New Roman font without italics or underlining, with single line spacing, 1 cm indentation and justified alignment. Author names and headings are typed in bold with centered alignment, no indentation. References are enlisted in alphabetical order in accordance with current bibliographic requirements.
- The text should contain the following information: initials and surname of the author(s), full title of the article, full name of the organization represented by the participant(s) (for example: Dubna State University, Protvino University branch, etc.), brief annotation (5-7 lines), text of the report and a list of references.
- The text may contain black-and-white figures and tables without graphic objects. All figures and tables should be entitled and enumerated.
- The equations and formulas referenced in the text should be placed on a separate line and should also be enumerated. All formulas should be made in *M.Equation 3.0*.
- The file containing the report should be named after the surname of its first author in Latin letters (for example: Alexeev.doc) and should be in the format of *.doc, *.docx or *.rtf.
- In case the submitted materials do not meet these specified requirements or contain violations of intellectual property rights, publication may be denied by the decision of the Program Committee of the Conference.
- The texts of the reports are not edited, their authors are responsible for the scientific content of the reports, style and grammar.
